

**WILLOWCREEK WOMEN'S GOLF ASSOCIATION  
GENERAL MEMBERSHIP MEETING  
MARCH 22, 2019**

**Call to Order** President, Marion Evans, called the meeting to order at 10 a.m. at Palmbrook Country Club.

**Approval of Minutes** Marion asked if there were any corrections or changes to the minutes of the Membership Meeting on February 5, 2019. No corrections/changes were offered. The minutes were approved as presented and posted.

**Treasurer's Report and Membership Report** Rhonda reported a ledger balance of \$3,769.90. Remaining budgeted items total \$1,561.25 with forward liabilities of \$1,792. Our status as a non-profit was suspended and is pending reinstatement. Should have final word about reinstatement this fall. **(UPDATE: We have been reinstated and are now fully compliant.)**

There are 117 members, five associate members, and twelve social members.

Rhonda indicated that our balance is too high and suggested that we may be able to reduce the dues by \$5 for the year 2019-2020. Discussion took place and a motion was made by Carol Arend that we reduce the dues by \$5. Chris Barnes seconded the motion and the membership voted. It was unanimously passed.

**President's Report:** Marion reported night golf outing on April 13. Octogenarian tournament participation April 15 and 19 is down and she encouraged participation from the group. Champion of champion dates are April 1, 4, and 6. Need volunteers to help with scoring on Thursday, April 4. She has the signup sheet. There was discussion about the way we pay out on tournaments. The motion to divide 1<sup>st</sup> and 2<sup>nd</sup> money was tabled until we can gather more input from members. Willowcreek is in favor of doing this. Mixer news – March 31 signup for April 11 mixer. Dinner will be \$12 per person.
